**Title: Evaluation of selected anthropometric and hormonal factors, levels of circadian rhythm regulator proteins, quality of life and sleep among students.**

Pursuant to the Act of December 5, 1996 on the professions of physician and dentist (Journal of Laws of 2017 item 125, as amended), the Act of September 6, 2001 - Pharmaceutical Law (i.e. Journal of Laws of 2016 item 2142, as amended), the Regulation of the Minister of Health of May 2, 2012 on sample documents submitted in connection with a clinical trial of a medicinal product and on the amount and manner of payment of fees for submission of an application for a clinical trial (Journal of Laws of 2012, item 491), the Act of May 20, 2010 on medical devices (Journal of Laws of 2017 item 211, as amended), the Regulation of the Minister of Health of February 17, 2016 on sample applications submitted in connection with a clinical trial, the amount of fees for submission of applications and the final report on the execution of a clinical trial (Journal of Laws, item 208), the Regulation of the Minister of Health and Social Welfare of May 11, 1999 on the detailed principles of appointment and financing and the mode of operation of committees for bioethics in medicine (Journal of Laws No. 47 item. 480), directive No. 8/2015 of February 16, 2015 of the Rector of the Medical University of Lodz on the introduction of the Regulations of the Committee for Bioethics in Medicine at the Medical University of Lodz and Directive No. 57/2017 of September 5, 2017 of the Rector of the Medical University of Lodz on the appointment of the Committee for Bioethics in Medicine at the Medical University of Lodz, the Committee for Bioethics in Medicine at the Medical University of Lodz, having analyzed the application, having read the draft opinion on the submitted study, in a secret ballot, (fulfilling the obligations of the ICH GCP) resolves as follows:

**§ 1**

1. to give a favorable opinion on the application, without objections, on the basis of the documents submitted, the list of which is set out in Annex 1. The resolution shall enter into force on the date of its adoption.

**§ 2**

The opinion relates only to the pending project application. Each change and modification requires a separate opinion. The applicant is obliged to inform of any corrections, adverse events and unforeseen circumstances. An appeal against this resolution shall be submitted via the Committee for Bioethics in Medicine at the Medical University of Lodz to the Appeals Committee for Bioethics in Medicine, within 14 days as of the date of receiving the resolution expressing the opinion.
